

## Costco/P&G ANZ Spend \$130 receive \$30 Shop Card Promotion Terms and Conditions

1. Information on how to enter and the prize(s) set out in all communication regarding this promotion (the "Promotion") form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Any entry not complying with these Conditions of Entry is invalid. Entry into this Promotion and the acceptance or receipt of a prize by any person is deemed as acceptance of these Conditions of Entry.
2. The Promoter is Procter & Gamble Australia Pty Ltd (ABN 91 008 396 245) of Level 4, 1 Innovation Road, Macquarie Park NSW 2113, telephone: 1800 028 280 (the "Promoter").
3. The Promotion commences 10:00AM AEST, 10<sup>th</sup> of June 2024 and closes on 6pm AEST, 7<sup>th</sup> of July 2024 ("Promotional Period"). All entries must be submitted between 10:00am AEST, 10<sup>th</sup> of June 2024 and 11:59 AEST, 21<sup>st</sup> of July 2024 ("Redemption Period").
4. In order to be eligible to participate in the Promotion, eligible participants ("Participants") must meet the requirements set out below. Participants must:
  - a. be residents of Australia or New Zealand; with a valid Costco Australia or Costco New Zealand membership number;
  - b. be 18 and over to enter the promotion and further, read and consent to these Terms and Conditions; and
5. Directors, officers and employees (and the immediate families of such persons) of the Promoter, its agencies and companies associated with this Promotion are ineligible to enter the Promotion. Entrants must then go to the online entry page ([pgpromo.campaign.net.au/costcoanzshopcard](http://pgpromo.campaign.net.au/costcoanzshopcard)), upload a copy of their receipt, input the requested details including full name, email address, receipt information and contact number, and submit the fully completed form during the Redemption Period. Each entrant will then be notified within five (5) business days whether or not entrant has qualified for the \$30 Costco Shop Card. From date of entrant is approved, entrant to receive \$30 shop card within fourteen (14) business days.

8. There is a limit of (a) two (2) redemptions per membership for the total duration of the promotion and (b) only two (2) entry permitted per transaction and per receipt; ie spend \$260, receive 2x\$30 shopcard. and (c) each entry must be submitted separately and in accordance with entry requirements (d) unrecognised receipts will be deemed invalid.
9. Entrants must retain the original purchase receipt(s) for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant's entries and forfeiture of any right to a shop card. Purchase receipt(s) must clearly specify the store of purchase is a Costco and that eligible P&G products were purchased during the Purchase Period but prior to entry.
10. Incomplete, indecipherable, or illegible entries will be deemed invalid.
11. Receipts with products, amounts and purchase dates that do not qualify will be rejected, and shop card will not be distributed
12. The Promoter reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
13. The Promoter reserves the right to disqualify any entrant submitting an entry which, in the opinion of the Promoter, includes objectionable content, including but not limited to profanity, nudity, potentially insulting, scandalous, inflammatory or defamatory images or language.
14. The Promoter and/or its agency may require the prize winner(s) to provide proof of identity, proof of age and/or proof of residence as a condition for claim of prize(s). Identification considered suitable for verification is at the sole discretion of the Promoter and/or its agency. The Promoter may and/or its agency may also request confirmation of postal address for the purposes of prize

18. Any ancillary costs associated with redeeming the prize are not included. Redemption of the prize is subject to any terms and conditions of the issuer including those specified on the prize.
